- Application for Peddler's License [PeddlersLicenseApplication.pdf](#)
- Vendor Fee Paid in Full (\$10/one day or \$25/year)
- Copy of identification (ID) provided
- Proof of Business Insurance (copy of valid policy required with \$2M coverage; must list the Village of Schuylerville as additionally insured)
- Festival Agreement

Food/Alcohol Compliance

- Saratoga County Department of Health Temporary Food Permit (if selling or serving food/beverages)
 - Apply *at least 10 days prior* to event with Saratoga County DOH at [Online Form](#).
 - Mobile Food Establishment Permits and Catering Food Establishment permits **are** acceptable for this requirement.
 - If you are unsure if you need a temporary food permit, please see [Temporary Foods – County of Saratoga, New York](#)
- NYS Liquor License (if selling or sampling alcoholic beverages)
 - If necessary, please make sure to apply directly with NYS Liquor Authority *at least 15 days prior* to the event [New York Business Express - One Day Alcohol Event Permit](#)

Final Approval: Please submit all items required above to a Turning Point Parade and Festival Committee member by **June 15th**. Once reviewed and approved, a permit will be issued for the day of the event. Please retain and display your permit at the event.

Day of the Event: Please remember to bring any electrical cords, lights, tables, a tent, etc that you may need the day of.

Whereas, the Renter desires to temporarily occupy and make use of the Owners venue, located at

I. EVENT DESCRIPTION/VENUE ACCESS: The Renter shall have access to and use of the venue from **9:00am** o'clock on 8/8/26, to **10:00pm** o'clock on **the same day**. _____

II. REMOVAL OF BELONGINGS: Renter shall remove all personal property, trash, and other items that were not present in the venue when Renter took control of it.

III. LIABILITY: Renter will be liable for any physical damages, legal actions, and/or loss of reputation or business opportunities that Owner may incur as a consequence of the actions of Renter or any of Renter's guests while Renter is in control of the venue, and shall indemnify and hold harmless the Owner against any and all legal actions which may arise from Renter's use of the venue.
